# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.gardenofcompassion.org, and Garden of Compassion Counseling & Consultation and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Garden of Compassion Counseling & Consultation include www.gardenofcompassion.org. The Garden of Compassion Counseling & Consultation website is a mental health private practice site. By using the Garden of Compassion Counseling & Consultation website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered, Garden of Compassion Counseling & Consultation may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Garden of Compassion Counseling & Consultation's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. # **Sharing Information with Third Parties**

Garden of Compassion Counseling & Consultation may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries.
